Subject: Extension of affiliation and change of category from Independent School to Government School in respect of Senior Secondary Navyug School, Mandir Marg, New Delhi beyond 31.03.2024 Reg.

Sir,

Navyug School Educational Society (NSES) is a registered Society under the Societies Registration Act-XXI of 1860 and 100% funded by the New Delhi Municipal Council (NDMC). The Society is running 11 Navyug Schools (07 Senior Secondary, 01 Secondary and 03 Primary Schools) under its control in NDMC area. NSES is making significant impact in the field of education in NDMC area by catering to quality education to about 9000 students through its 11 schools. **“SENIOR SECONDARY NAVYUG SCHOOL, MANDIR MARG, NEW DELHI”** is one of the Navyug Schools established in the year 2008 by the NDMC. The expenditure on account of payment of salary & allowances to the employees working in Navyug Schools is borne by the NSES out of the grant-in-aid received from NDMC.

2. The above said school is equipped with reference to infrastructure and human resources to provide quality education to the children. First batch of Class-10 appeared in 2010-2011 and Class-12 appeared in 2012-2013. The school is at present affiliated with CBSE vide No. 2730608 under Independent Category and CBSE Code No. 85023 (**Annexure-I**). The validity of the affiliation of the said school is upto 31.03.2024.

3. The school does not run for profit and is offering academic programmes for Class-1 to Class-12 to the students residing in NDMC area without any discrimination based on religion, caste, race, place of birth etc. The school fulfils the regulatory requirements of CBSE & State and not charge any kind of tuition fees.

4. As per Chapter-II of Affiliation bye-Laws, CBSE affiliate different categories of schools all over India and abroad from rule 2.1.1 to 2.1.10. Further rule 2.2.6 says that one time regular Affiliation will be granted to the categories of schools covered under clauses 2.1.1, 2.1.2, 2.1.3 and 2.1.4. Clause 2.1.3 covers the schools run by Autonomous Organizations under Government created for running schools like Kendriya Vidyalaya Sangthan, Navodaya Vidyalaya Samiti, central Tibetan Schools Organization, Sainik Schools Society etc. henceforth be put under regular affiliation. In this regard information given in Para-1 above may be referred to.

5. It is further informed that 04 Navyug Schools at Lodhi Road, Laxmibai Nagar, Moti Bagh and Pandara Park have already been placed under the Government School Category by the CBSE (**Annexure-II to IV**).

6. In view of the above, it is requested that **SENIOR SECONDARY NAVYUG SCHOOL, MANDIR MARG, NEW DELHI** may kindly be placed under the Government School category for one time regular affiliation. It is also requested that the school may be given extension of affiliation beyond 31.03.2024. Necessary documents as required by the CBSE for extension and change of category are enclosed herewith.
